

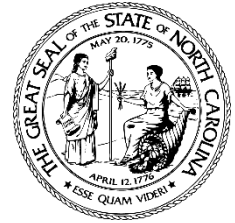

- Adjournment resolutions
- Bills proposing amendments to the North Carolina Constitution
- Statutory changes necessary to implement State constitutional amendments
- Bills addressing election laws
